## The Direct Debit Guarantee

If an error is made in the payment of your Direct Debit by the Scottish Chamber Orchestra or your Bank or Building society you are entitled to a full and immediate refund of the amount paid from your Bank or Building society. If you receive a refund you are not entitled to, you must pay it back when the Scottish Chamber Orchestra asks you to. You can cancel a Direct Debit at any time by simply contacting your Bank or Building society. Written confirmation may be required. Please also notify us.
